1. Payment Schedule & Deposit

- **Booking Retainer (Deposit):** A non-refundable retainer of 50% of the Total Contract Price is due upon signing this contract to secure the event date and time.
 - Retainer Amount Due: \$ _____
 - Date Retainer Paid: \$ _____
- **Final Payment:** The remaining balance is due 14 days prior to the scheduled Event Date. Failure to submit the final payment by the due date may result in cancellation of services.
- **Gratuity:** Gratuity is not included in the contract price and is left to the Client's discretion.

2. Minimum Service Requirement & Changes

- **Service Minimum:** A minimum booking requirement of 4 total paid services (e.g., 1 Bride service + 3 Bridal Party services) is required for on-location booking.
- **Adding Services:** Services may be added up to 30 days prior to the Event Date, subject to stylist availability. The Client must notify the Salon immediately to adjust the invoice.
- **Reducing Services/Cancellations:** A reduction in the number of services is not permitted within 60 days of the Event Date. The Client is responsible for paying the original Total Contract Price if services are reduced within this timeframe.

3. Travel & On-Site Fees

- **Travel Fee:** A flat rate fee of \$ _____ or a fee of \$ _____ per mile (round trip) will be charged for any location outside a 10-mile radius from the Salon. This fee is included in the Total Contract Price.
- **Parking/Tolls:** Any necessary parking, valet, or toll fees incurred by the Service Provider will be added to the final balance, or they must be provided and paid for by the Client upon arrival.

4. Trial Run (Required)

- A hair and/or makeup trial run is required for the Bride and must be completed prior to the date of booking this contract to ensure the stylist is the right fit. The trial run cost is separate from this contract and must be paid at the time of the trial.

5. Cancellation Policy

Client Cancellation:

- If the Client cancels the contract more than 60 days prior to the Event Date, the 50% retainer will be refunded.
- If the Client cancels the contract 60 days or less prior to the Event Date, the Client is responsible for paying 100% of the Total Contract Price.

Stylist Cancellation (Force Majeure):

- In the unlikely event the assigned stylist is unable to perform services due to unforeseen circumstances (e.g., illness, accident, acts of God), the Salon will make every effort to provide a suitable replacement stylist. If a replacement cannot be secured, the Salon will issue a full refund of all moneys paid, excluding the cost of services already rendered (like the trial). The Salon's liability is limited to the refund of payments made under this contract.

6. Client Responsibility

- The Client agrees to provide a safe, well-lit, and clean working environment with adequate working space and electrical outlets at the location of service. All members of the Bridal Party must arrive with clean, dry hair and a clean, moisturized face unless otherwise instructed by the stylist.
